SIDEWRITE OFFICIAL RULES & CONDITIONS

1. Sidewalk SideWrite is a short screenplay competition, a project of the Alabama Moving Image Association (AMIA).
2. The SideWrite contest is open to writers who are Alabama residents.
3. Collaborative work is eligible, but each author must sign the entry form. The writers are responsible for the distribution of the contest prize(s).
4. Multiple submissions are acceptable, but each screenplay **MUST** be submitted with a separate Entry Form and Entry Fee.
5. The submitted screenplay may not invade or defame the rights of any person, living or dead.
6. The submission must be original work. **No adaptations will be accepted.**
7. The submission must not have been previously optioned, sold, or produced.
8. Entering this contest will not limit your copyright in any way. You retain the rights to your original screenplay.
9. Grand Prize Winner will be determined by jury, and announced at the 2006 Sidewalk Moving Picture Festival Awards Show.
10. The Production Prize Winner will be chosen by an AMIA affiliate production company, slated to produce the winner.
11. No additional fee is required to be considered for the production prize.
12. Screenplays are limited to **15** pages in length.
13. All submissions must use **12 point Courier font** and have no smaller than **one inch margins**.
14. All submissions must have a **title page** containing: **the title, author's name, e-mail address, phone number**. The author's name shall not appear on any page but the title page.
15. All submissions must be in paper form, no electronic submissions will be accepted.
16. The entry fee for each submission is \$15, or \$10 for Sidewalk members.
17. Screenplay submissions must be postmarked no later than **August 1, 2006**.
